The Proposed Allottee(s) for CCDs and Warrants have expressed their intent to subscribe to the Securities.

- (iii) The consideration for allotment of CCD shall be paid to the Company from the bank account(s) of the Proposed CCD Allottee.

Further, the Proposed Allottees has also undertaken that they will not deal in the equity shares of the Company till the allotment of CCDs and Warrants is completed.
