<u>Subject: Outcome for allotment of equity shares and convertible warrants to non-promoters on preferential basis</u>

Dear Sir/Madam,

Pursuant to Regulation 30 of Securities and Exchange Board of India ("SEBI") (Listing Obligation and Disclosure Requirements), Regulations, 2015, as amended, we wish to inform you that the Finance Committee of Dhanvarsha Finvest Limited has, inter alia, approved:

 allotment of 9,83,230 equity shares having face value of Rs.2/- each at a premium of Rs.130/- per share aggregating to Rs. 12,97,86,360/-

allotment of 27,74,706 convertible warrants having issue price of Rs.132/- on preferential basis to non-promoters aggregating to Rs.36,62,61,192/-, convertible within a period of 18 months into equivalent equity shares having a face value of Rs.2/- per share (at a premium of Rs.130/- per share), wherein pursuant to Regulation 169(2) of SEBI (Issue of Capital and Disclosure Requirement), Regulations, 2018, as amended, the Company has received 25% of the consideration upfront from the allottees amounting to Rs. 9,15,65,298/-.

Consequently, the paid-up equity share capital of the Company has increased from Rs. 21,18,16,116/- comprising of 10,59,08,058 equity shares of Rs.2/- each to Rs.21,37,82,576/- comprising of 10,68,91,288 equity shares of Rs.2/- each.

The aforementioned equity shares allotted and the equity shares that will be allotted upon exercise of conversion of warrants shall rank pari-passu with the existing equity shares of the Company.
